Definitions

- 5. operator any natural or legal person, of private or public law, including public authorities, their institutions and territorial structures, which establishes the purpose and the means of processing personal data;
- 6. third party any natural or legal person, under private or public law, including public authorities, their institutions and territorial structures, other than the data subject, the operator or authorized person or the persons who, under the direct authority of the operator or person authorized, they are authorized to process data;
