

## **Terms and conditions**

### **User Contract**

#### **Part I – Terms and conditions for the students**

##### **Agreement with students**

This agreement regulates and contains all terms and conditions of use by a user of the platform services Engleza-Online.com.ro (also referred to as "platform" or "Site") registered as a learner ("learner", "user" or "student"). By agreeing to the terms and Conditions of this Agreement, you also agree to the [Privacy Policy](#) contained therein.

##### *Definition of services*

#### The use of Engleza-Online.com.ro

You will be solely and fully responsible for any conduct, posts or transmissions made on your behalf and with your password you warrant and declare that as long as you use Engleza-Online.com.ro you will act according to the following rules:

1. The learner is solely responsible for verifying the identity of the instructor, his qualifications, accreditation letters, biographical information or licenses held and other information supplied by him.
